SUBJECT: **WIA Directive No. 02-34
PY 01-02 WIA Supplemental Youth Funds**

The purpose of this directive is to inform all WIA Youth Opportunities System Lead and Joint contractors that the City of Los Angeles has received notification from the State Employment Development Department of WIA Supplemental Youth Funds for PY 2001-2002 in the amount of \$770,964.

It is the intention of the Community Development Department/Workforce Development Division to allocate these supplemental funds to the existing WIA youth service providers in the 10 School-to-Career Areas. The formula for allocation will be the same used for the 2000-2005 WIA Youth Opportunities System Request for Proposal which was based on the percentage of youth in poverty per Consortia Area using census data. This allocation method is consistent with the Workforce Investment Board's (WIB) adopted Re-allocation Policy for Youth System Funding.

Attached you will find a WIA Supplemental Funding Allocation Matrix that outlines the distribution of funds and the additional number of youth to be served per Consortia Area. Based on this matrix, please provide us with the allocation of funds by agency in your consortia area for contracting and budget modification purposes no later than February 15, 2002.

The information regarding the supplemental funds will be presented to the Youth Council on February 13, 2002. A transmittal to approve the acceptance and allocation of these additional funds by the City Council and Mayor is concurrently being prepared by staff. Upon approval by Youth Council, City Council and Mayor, a separate contract amendment will be negotiated and prepared for the supplemental funds. In the interest of time, please begin preparing your budget modification incorporating all additional funds.
